Private sector lender Kotak Mahindra Bank, which is planning to raise about Rs 5,662 crore by selling 6.2 crore shares through Qualified Institutional Placement (QIP) has set the floor price at Rs 913.24 per equity share as part of the issue, it said in a filing on Thursday. The share sale is part of the stake dilution exercise by the promoter Uday Kotak, the Vice Chairman of the bank. The Reserve Bank of India (RBI)'s regulatory guidelines require the promoters of the bank to bring down their holding in a phased manner - 10 per cent by June 30, 2017, 20 per cent by December 31, 2017 and 15 per cent by March 31, 2020. As of March 31, 2017, promoters held 32.08 per cent stake in the bank of which Uday Kotak himself held 31.77 per cent. The public shareholding in the bank was 67.92 per cent. In a regulatory filing, the bank said the security issue is part of the board of directors of the bank. The board meeting on Thursday approved the opening of the QIP to May 11, 2017 and took on record the floor price of Rs 913.24 per equity share. At this price, the bank's shares are worth Rs 5,662 crore. The proposed dilution works out to 3.37 per cent of the current equity base. The bank's board had earlier approved a QIP to raise capital through an equity offer by the bank to 6.2 crore shares of Rs 5 each.

## Google expand partnership with Chromebooks adoption

Cloud services provider VMware on Friday announced its partnership with Google to accelerate the adoption of Chromebooks. With its "Workspace ONE" platform that unifies IT management for IT, VMware will enable one-click authentications of applications for users deploying these laptops. The two companies also collaborated on efforts to unify native Android apps. "From Windows to web to mobile apps, Workspace One will allow our customers to securely deploy applications on Chrome OS devices," said Rajen Sheth, Director (Product Management) OS Google. According to the market research firm International Data Corporation (IDC), applications are a major factor in the success of a mobile operating system and growth in the application ecosystem has improved the user experience with the platform.
