Pursuant to Reg. 44(1) & (2) of the Listing Regulations read with section 108 of the Companies Act, 2013 and Rule 20 of Companies (Management and Administration) Rules, 2014 and its Amendment Rules, 2015, the company has made arrangement with Central Depository Services (India) Ltd (CDSL) to provide e-voting facility for voting on resolutions set forth in the Notice of AGM. Members of the company holding shares in physical form as per the Register of Members of the Company or dematerialized form as per the Register of Beneficial Owners maintained by the Depositories as on Cut-off date i.e. Friday 16th September, 2016, may cast their vote electronically.

The remote e-voting period commences on Tuesday, 20th September, 2016 at 9.00 a.m. and will end on Thursday, 22nd September, 2016 at 5.00 p.m. The remote e-voting module shall be disabled for voting thereafter and shall not be allowed beyond the said date and time.

In case a person has become Member of the company after dispatch of AGM notice but on or before the Cut-off date i.e. Friday 16th September, 2016, he may obtain user id and password by sending request at helpdesk.evoting@cdslindia.com. If the Members is already registered with CDSL for e-voting, the Member can use the existing user id and password for casting vote through remote e-voting. A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by depositories as on the Cut-off date only shall be entitled to avail the facility of remote e-voting or voting at the AGM through ballot paper. The facility of voting by ballot paper shall be made available at AGM and the member attending the AGM who have not cast their vote by remote e-voting, shall be eligible to vote at the AGM. Historic Dell-EMC \$67 bn deal to close on September 7

New York, The world's largest \$67 billion technology merger between EMC Corporation and Dell Technologies is all set to close on September 7 after China granted the regulatory clearance. Dell Technologies, the name of the new combined company, will begin operating immediately following the close of the transaction, Dell said in a statement on Tuesday. The announcement follows the regulatory approval of the Dell and EMC transaction by China's Ministry of Commerce which has granted clearance for the companies' proposed combination.

EMC shareholders had approved the transaction on July 19, with approximately 98 percent of voting EMC shareholders casting their votes in favour of the merger, representing approximately 74 percent of EMC's outstanding common stock. "This is an historic moment for both Dell and EMC. Combined, we will be exceptionally well-positioned for growth in the most strategic areas of next generation IT including digital transformation, software-defined data center, converged infrastructure, hybrid cloud, mobile and security," said Michael Dell, chairman and CEO of Dell Tech-

nologies. "Our investments in R&D and innovation, along with our 140,000 team members around the world, will give us unmatched scale, strength and flexibility, deepening our relationships with customers of all sizes," he added. At closing, EMC shareholders will receive \$24.05 per share in cash in addition to a newly issued tracking stock linked to a portion of EMC's economic interest in the VMware business. Based on the estimated number of EMC shares outstanding at the close of the transaction, EMC shareholders are expected to receive approximately 0.111 shares of new tracking stock for each EMC share. "I am proud of everything we've built at EMC - from humble beginnings as a Boston-based startup to a global, world-class technology company with an unyielding dedication to our customers," said Joe Tucci, chairman and chief executive officer of EMC. "The combination of Dell and EMC creates a new powerhouse in the industry - providing the essential technology for the next era in IT," he added. Dell announced in October last year a merger with EMC - the top multinational in computer storage and cloud computing. Dell is a leader in PC technologies in the middle and lower segments.

Sony Pictures to acquire sports channels of Zee for \$385 mn

New Delhi, Sony Pictures Networks India on Wednesday announced it is acquiring the sports broadcasting business of Zee Entertainment for \$385 million in an all-cash deal.

"Zee's TEN Sports channels being acquired include TEN 1, TEN 1 HD, TEN 2, TEN 3, TEN Golf HD, TEN Cricket, TEN Sports that operate in several countries including the Indian sub-continent, Maldives, Singapore, Hong Kong, Middle East, Caribbean," a company statement said. TEN Sports holds cricket rights in South Africa, Pakistan, Sri Lanka, West Indies and Zimbabwe.

It also holds the rights for world wrestling, some football leagues, WTA and ATP tennis events, golf tours, Asian and Commonwealth Games athletics, motor sports and cycling events, including Tour de France.
